MACALI APS SOFTWARE END USER LICENSE AGREEMENT January 2019

1. Scope of licence Macali APS (hereinafter Macali APS) hereby grants licensee(a company/VAT Number) a non-transferable and non-exclusive right of use for the supplied program (s)/program module (s) from MACALI APS (hereafter referred to as the software) and the corresponding documentation. The right of use only covers the licensee's own use of the software, and licensee, is thus unjustified to transfer/transfer the right of use, regardless of whether this may be done by sale, lease or lending etc., or otherwise allow third parties access to the use of Software. The right of use covers only the number of users to whom the licensee has acquired rights. The right of use is conditional on the licensee paying for the purchase of software and the current compulsory use and service charge. Where there is a compulsory subscription, the right of use shall continue to be maintained and paid by the licensee for the mandatory continuous TOTAL use/service subscription at Macali APS at all Acquired software and the agreement has not ceased under this agreement, including, inter alia, the Section 11 on termination. MACALI APS May On certain products, of their choice, offer that the licensee pays a lump sum to MACALI APS for an indefinite right of use without the corresponding Usage/service subscription. Upon termination of the use/service subscription, MACALI APS will remove the right of use after the expiry of the last use/service period. If the licensee does not pay invoices for the due date, the right of use is void in its entirety and a Continued use of the software violates the rights of MACALI APS .

2. Terms of delivery and payment when the term "delivery" is used in this License agreement, the time at which the software is shipped from MACALI APS to the licensee or installed on its system and put into service is considered possibly. The creation fee is billed by MACALI APS upon delivery of the software. The current compulsory use/service charge will be invoiced in advance for one year at a time (the period of services). Invoices are due for payment 8 days after invoice date, and if invoiced amounts are not paid to maturity, Macali APS is entitled to interest on arrears of 1.5% per commenced month, without any further claim for interest. When sending reminders for late payment, MACALI APS imposes a reminder fee of a MINIMUM of DKK 250.00 for each.

3. Copying licensee may make the necessary copying in order to be able to use the software, including installation on the licensee's equipment. In addition, licensee is entitled to copy the software for backup purposes. Licensee shall not be entitled to produce any further copies and the abovementioned admissible copies may not be transferred to third parties. The seller licenses the equipment to third parties on which the software is installed, the licensee must make sure to delete the software prior to the surrender of the equipment to third parties. Licensee shall not be entitled to use the content of the following databases in the software in a different context than with the software.

4. Modifications and adaptations Licensee shall be entitled to make the necessary changes and adaptations, in the copies of licensees, that are supported by the software in order for the software to be used for its intended purpose. Licensee must, however, be aware that changes/adaptations to the software that are not made by MACALI APS may void the liability of MACALI APs in whole or in part, as changes/adaptations may cause problems, e.g. in the form Of the disappearance of functionality, in particular in relation to future updates, etc. from MACALI APS.

5. Intellectual property Rights MACALI APS has all rights to the software, including all copyrights, trademark rights and other intellectual property rights. Any violation of the rights of MACALI APs shall be deemed to

be a material breach of this License agreement. Licensee may not break or modify license codes, change/Remove module-specific serial numbers, rights-related claims, trademarks and the like.

6. The rights of third parties MACALI APS warrants that the software does not infringe the intellectual property rights of third parties. If third parties raise objections regarding the use of the software, licensee must notify MACALI APS immediately. In the event of such notification, MACALI APS may choose to take over the matter and any expenses related to it. MACALI APS has the right to take over the case at its own expense, including the interests of MACALI Aps during a possible trial, and to settle the alleged infringements. In the event that a third party succeeds in the existence of an infringement either in the form of a final judgment or an arbitration decision, MACALI APS is obliged at its own expense to either 1) obtain the continued right to use the software, or 2) bring Termination by modifying the software, or 3) replace the software with another product that generally contains the same features as the software or 4) without notice terminate this License agreement and promptly repay the applicable rights/service charge, which the licensee has paid to MACALI APS from the time of the occurrence of the infringement, however, the minimum use/service charge paid for the current legal/service subscription period. Upon termination of this License agreement, licensee is obligated to uninstall the software, including but not limited to updates, new releases and new versions, and also to destroy any backup and/or archived copies of Same. In addition to the above obligations, MACALI APS does not have any other obligations or responsibilities and licensee cannot exercise any remedies other than those in force as a result of infringement of the rights of third parties; Claims for damages, regardless of the degree of negligence.

7. Authorization and logging licensee agrees that MACALI APS may perform authorization checks at startup of program and logs the use of functions in the program. The information is used solely to check licensee's rights of use of the program, and in the work to further develop-and improve the software. The information is not disclosed to third parties.

8. licensee 's choice of product from Macali APS software is standard products THAT CAN BE used "as is" and Macali APS bears no responsibility for whether the software meets the requirements and wishes of licensees .

9. Remedying of defects and deficiencies MACALI APS draws attention to the fact that it is not practically possible to produce software that can be run flawlessly in all situations and combinations. Licensee is encouraged to install and test the software immediately after delivery. For a period of 3 months after delivery, MACALI APS warrants to be able to provide the software if, due to errors in the data media on which the software is provided or errors related to downloading, it proves impossible to install the software, as described in the Accompanying documentation, etc. However, this does not guarantee that the software can be installed, as the setup etc. of licensees ' equipment and system may cause difficulties or render a suitable installation impossible. If licensee advertises in writing any material defects in the software which result in the vital functions of the software not being executed, MACALI APS will, for a period of 6 months after delivery of the software, be obliged to either 1) without charge to Provide a new flawless version of the software, or 2) within a reasonable time to correct the error at no charge, provided that the error can be recreated at MACALI APS and corrected by MACALI APS, or (3) to return the licensed user/service charge for the Software for the period from the time of the licensee's claim, provided that the licensee uninstall the software and deletes all copies of the software in question. Debugging may consist of instructions and recommendations to circumvent the error so that the fault no longer has a material impact on licensee's use of the software. MACALI APS also strives to remedy non-material errors and inappropriately. However, such bug fixes, etc. will only be released in the form of future updates. However,

in order to receive such future updates, Licensee is required to sign a service subscription that is in effect at the time of the claim. The right of use is provided to the software as is and does not include any other warranties, representations, remedies or remedies other than those described above. Thus, licensee may not, in addition to the aforementioned, raise claims against MACALI APS due to defects in the software or as a result of the fact that MACALI APS does not fix such defects or that the processing and performance of the software is not free of interruptions or Error.

10. Liability limitation MACALI APS may under no circumstances be liable for any indirect loss or consequential damages, such as Loss of expected earnings, expected support or payouts, loss of profit, goodwill, or damage to other licensees ' data or databases, or loss of any other type of business interruption that may arise from the use of the software or Incomplete/Insufficient performance of the software. A number of functions and calculations in the Software can be based on 3. parts Software or service and its functioning. In this the case Macali APS is continually looking to keep up to date with its development BUT DOES NOT warrant to have knowledge of all functions and modes of operation, guides, etc. in the field. Functions, recommendations and indications may, in certain cases, result from the use of Macali APS and their interpretation Macali APS seeks best way to interpret the third-party software or service, BUT DISCLAIMS ANY liability for accuracy, and the results of use of In the software. ANY USE OF The RECOMMENDATIONS AND USE of the Macali APS SOFTWARE IS therefore SOLELY at the LICENSEE'S OWN risk, and Macali APS disclaims all liability to the licensee or to a third party. MACALI APS DOES NOT WARRANT THAT The FUNCTIONS of the SOFTWARE SUPPORT all functions. Macali Aps's total liability for loss and damage shall not exceed the amount paid in the use/service charge for the software in question. The aforementioned disclaimers also apply to product liability, since the scope of mandatory legal provisions does not preclude such a waiver. Force Majeure None of the parties may be held liable for any damage suffered by the other party as a direct or indirect consequence of the delay or unaccountability of the party, due to a Force majeure situation, in carrying out its obligations under this License agreement. Force majeure situations include: War, mobilisation, natural disasters, strikes, lockout, fire, water damage, import and export restrictions, virus attacks, and other unforeseen circumstances which the Party concerned cannot prevent through the unfolding of reasonable measures.

12. Duration and termination of the contract the licensee may terminate this agreement by terminating the mandatory use/service subscription. At the same time, the licensee's termination of the compulsory use/service subscription automatically entails the termination of this Agreement by the licensee and the licensee's right of usage is then terminated at the end of the mandatory Service subscription. Macali APS may terminate this agreement at any time with 3 (three) months ' notice. By MACALI APS's termination of the agreement, may be refunded by licensee prepaid fee for the use/service subscription for the period after termination of the agreement.

13. Transfer licensee may not assign rights and obligations under this Agreement to any third party. MACALI APS may assign rights and obligations under this Agreement, in whole or in part, to third parties, without the prior consent of licensees.

Licensee 's default is in breach of this License agreement in connection with the use of the software FOR EXAMPLE, Macali APS's copyrights are infringed by making copies in violation of This agreement, or transfer copies of the software to third parties, or defaulting on payment obligations, licensee is liable under the general rules of the Danish court. In addition, MACALI APS may revoke the rights of use of licensees, under which the licensee is no longer entitled to operate the software, in which case licensee is obliged to delete all copies and versions of that software.
